- ❖ After the last date of payment for each quarter, a late fee will be applicable.
- ❖ From 16th-30th of the month, a late fee of Rs. 20/- per day will be levied. Thereafter, a late fee of Rs. 50/- per day will be applicable for the next 15 days. After 15th, the Transport Facility shall be withdrawn.

FEE WAIVER POLICY

1 ACADEMIC EXCELLENCE WAIVER

- ❖ Students scoring above 95% in the entrance examination (Grades UKG to XI) will be eligible for a 50% waiver on the admission fee.
- ❖ Students scoring above 90% in the entrance examination (Grades UKG to XI) will be eligible for a 25% waiver on the admission fee.

2 SPORTS ACHIEVEMENT WAIVER

- ❖ Students who have Participated at the National level will be eligible for a 100% waiver of the admission fee. They must provide a valid certificate.
- ❖ Students who have Participated at the State level will be eligible for a 50% waiver of the admission fee. They must provide a valid certificate.
- ❖ Students who have Participated at the District level will be eligible for a 25% waiver of the admission fee. They must provide a valid certificate.

3 PHYSICAL DISABILITY PARENT WAIVER

- ❖ Children of parents with physical disabilities, upon submission of a valid medical certificate, will be eligible for a 25% waiver on the admission fee.

4 SINGLE PARENT WAIVER

- ❖ Children of single parents will be eligible for a 25% waiver on the admission fee. The parent must submit a valid certificate as proof.

5 DEFENCE PERSONNEL WAIVER

- ❖ For Parents currently serving in the Armed forces or have retired from the Armed Forces, 25% admission fee will be waived off on the admission fee.

6 INTERNAL TRANSFER WAIVER

- ❖ For children currently studying in an authorized Delhi Public School, 25% admission fee will be waived off.

7 SIBLING WAIVER

- ❖ For siblings, 25% admission fee will be waived off on the second child

1. Transport Fee (As per Distance)

- School Transport: Seats on the School transport are offered on a first come - first served basis and depend on their availability. The fee for the School's own fleet is to be paid in the School's Accounts Office/ERP along with the quarterly School fee.
- All students using the school bus are expected to be at the bus stop at least five minutes before the arrival time of the bus.
- The buses will not wait for the late-comers.
- The drivers are authorized to stop buses at the designated stops only, unless otherwise directed by the school.
- Students will be held responsible for any damage to buses caused by their negligence.
- Misbehavior/indiscipline like screaming and shouting or other discipline behaviour in the bus or non-payment of bus fee may lead to cancellation of the bus facility for the student. The school retains the right to deny the facility to anyone without assigning any reason whatsoever.
- Parent desiring to discontinue the transport service are required to intimate to the Transport In-charge in email/or in written at least 1 month in advance or pay one-month bus fare in lieu therefore.
